

**KHKI “DAN AND SHAY - SPEECHLESS” CONTEST  
OFFICIAL RULES**

A complete copy of these rules can be obtained at the offices of radio station KHKI (“Station”), owned and operated by Cumulus Radio LLC 4143 109<sup>th</sup> St, Urbandale, Iowa, 50322, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KHKI “DAN AND SHAY - SPEECHLESS”** Contest (the “Contest”) substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

**Eligibility.** This Contest is open only to legal U.S. residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station’s Designated Market Area (“DMA”) as defined by Nielsen Audio, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last sixty (60) days, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last sixty (60) days. **Void where prohibited by law.** Employees of Cumulus Radio LLC, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station’s DMA, and the immediate family members and household members of all such employees are not eligible to participate. **On-Air:** Listen to the Station from 6:00 a.m., CT to 7:00 p.m., CT during the Contest Period. When the Station plays the “cue-to-call” sounder, listeners should call the Station at 515-312-0973. Caller number seven (7) to the Station, as determined by the Station in its sole discretion, will be played a clip of a song, the caller must finish the lyrics after the music stops. If they fill in the lyrics correctly, they will win the prize. ***Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:*** Due to the time delay that exists between the Station’s analog over-the-air signal and the Station’s online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station’s analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Winner Selection.** Caller number seven (7) as described above, will win a call-in prize if they name the song correctly (subject to verification of eligibility and compliance with the terms of these rules). The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station’s decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest.
