NASH FM 97.3'S "HINTERLAND TEXT FOR A CHANCE TO WIN" CONTEST OFFICIAL RULES

The Station will conduct the NASH FM 97.3's "HINTERLAND TEXT FOR A CHANCE TO WIN" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. When the Station announces the Contest keyword, entrant must send a text message with the keyword spelled correctly to 515-312-0973 during the Contest Period. All entries must be received by 11:59 PM CT on November 6, 2022 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

4. Winner Selection. On or about 10:00 AM CT on November 7, 2022, Station will select Two (2) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period.
