NASH FM 97.3'S "WYNONNA JUDD ONLINE CHANCE TO WIN WEEKEND" CONTEST OFFICIAL RULES

The Station will conduct the Nash FM 97.3's "Wynonna Judd Online Chance to Win Weekend" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
