NASH FM 97.3'S "ZACH BRYAN TEXT FOR A CHANCE TO WIN" CONTEST OFFICIAL RULES

The Station will conduct the NASH FM 97.3's "ZACH BRYAN TEXT FOR A CHANCE TO WIN" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age Twenty-One (21) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 30 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the 30 days. The Contest is subject to all applicable federal, state and local laws and regulations. (each "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. How to Enter.

<u>Text</u>: Listen to the Station at least one hour during one or both Contest Periods. When the Station announces the Contest keyword for that Contest Period, entrants must send a text message with that Contest Period's keyword spelled correctly to 515-915-0973 by 11:59 PM CT on that day. Each day's keyword will be announced at least once each hour during the Period. All entries must be received by 11:59 PM CT on July 30, 2023 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

4. Winner Selection. On or about 10:00 AM CT on September 5, 2023, Station will select Four (4) potential winner(s) in a random drawing from among all valid entries received by Station during both Contest Periods. Each winning entrant will be contacted using the telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial

verification contact within twenty-four (24) hours of notification or failure to claim the prize within twenty-four (24) hours of verification as a winner will result in disqualification and forfeiture of the prize.

- 5. Verification of Potential Winner.
